<sup>3</sup> Because tuition revenue for the Walton College MHA Program in the College of Public Health is collected on the University of Arkansas at Fayetteville campus, and not by the UAMS College of Public Health, it has been removed from this schedule. UAMS is compensated for its participation in the Walton College EMBA program through a Memo of Understanding between the two institutions. Revenue flows to UAMS through billings done by the UAMS Contracts Office and posts as contract revenue, not as tuition revenue.
