## Arkansas Academic Challenge Scholarship

### Establishment

Acts 352, 362 and 733 of 1991 established the Arkansas Academic Challenge Scholarship Program, followed by numerous changes through the years until Acts of 2009, Act 605, § 4, eff. March 25, 2009; Acts of 2009, Act 606, § 4, eff. March 25, 2009; Acts of 2013, Act 1173, § 14, eff. April 12, 2013; Acts of 2013, Act 1269, § 1, eff. Aug, established it as the scholarship to be funded by the Arkansas Scholarship Lottery.

### Purpose and Need

In approving Arkansas Constitution, Amendment 87, the citizens of this state provided an opportunity to increase the resources provided for higher education scholarships and grants through a state lottery. The purpose of this scholarship program is to increase student success, reduce student loans, and prepare more students for high wage and high demand jobs to benefit Arkansas's economy. Also to increase the percentage of adults in Arkansas that hold a college degree.

### Eligibility Requirements

Traditional: Graduated from an Arkansas high school or home school and has achieved a minimum composite score of nineteen (19) on the ACT, or the equivalent score on an equivalent test. Students graduating from an out-of-state high school may also qualify if the student is, or has at least one parent who is, an Arkansas resident.

Nontraditional: Graduated from an Arkansas public high school and achieved a 2.5 high school grade point average but has not successfully completed at least twelve (12) semester hours of credit of courses; or Graduated from an Arkansas public high school, a private high school, an out-of-state high school, a home school high school, or obtained a high school equivalency diploma approved by the Department of Career Education and either: a minimum composite score of nineteen (19) on the ACT or the equivalent score on an ACT equivalent; or has successfully completed at least twelve (12) semester hours of courses granting three (3) or more hours of credit per course at an institution of higher education and earned a postsecondary grade point average of at least 2.5.

## **Arkansas Geographical Critical Needs Minority Teacher Scholarship**

*This program is administered by the University of Arkansas at Pine Bluff*

### Establishment

Acts of 2001, Act 1731, § 2, eff. Aug. 13, 2001; Acts of 2003, Act 1746, § 1, eff. July 16, 2003.

### Purpose and Need

The purpose of the program is to attract qualified minority teachers to the Delta and those geographical areas of the state where there exists a critical shortage of teachers by awarding scholarships to minorities declaring an intention to serve in the teaching field who actually render service to this state while possessing an appropriate teaching license.

### Eligibility Requirements

The scholarship is available to full-time or part-time undergraduate students who are Black-American, Hispanic-American, Asian-American or Native-American with a GPA of at least 2.5 in the core curriculum. Students must agree in writing of an intention to teach in the Delta or a geographical area of the state in which there exists a critical shortage of teachers. Students must have scored nineteen (19) or above on the ACT composite or the equivalent. This program is administered by the University of Arkansas at Pine Bluff. Full-time up to \$1,500.00, part-time up to \$750.00.

## Arkansas Governor's Scholars Program

### Establishment

Acts of 1983 (Ex. Sess.), Act 59, § 3; Acts of 1985, Act 176, § 1; Acts of 1997, Act 489, § 1; Acts of 1997, Act 1269, § 2, eff. April 9, 1997; Acts of 2001, Act 1761, § 2, eff. April 30, 2001; Acts of 2009, Act 1218, § 1, eff. April 7, 2009; Acts of 2013, Act 416, § 1, eff. Aug. 16, 2013.

### Purpose and Need

The Governor's Scholars Program is a scholarship program to promote academic excellence and to encourage the state's most talented graduates to enroll in Arkansas postsecondary educational institutions. The General Assembly recognizes that outstanding students are an essential ingredient for the economic and social benefit of the state of Arkansas. Benefits accrue to the state when a majority of National Merit Scholars, National Achievement Scholars, and superior students attend Arkansas institutions of higher learning and remain in the state.

### Eligibility Requirements

Governor's Distinguished Scholars are awarded \$10,000 per year, or tuition, mandatory fees, room and board, whichever is less. In order to qualify as a Governor's Distinguished Scholar, students must have a 32 ACT or 1410 SAT and either a 3.5 over-all GPA or be designated as National Merit and National Achievement Finalists.

If there are counties in Arkansas that do not have a Governor's Distinguished Scholar according to the above criteria, the highest ranking Academic Challenge Scholarship applicant will be selected as that county's Governor's Distinguished Scholar.

### Purpose and Need

The Arkansas Health Education Grant (ARHEG) Program provides assistance for Arkansas residents attending certain out-of-state accredited health and medical professional schools for graduate or professional programs that are not available in Arkansas. The availability of a forgivable loan, in addition to the grant, serves ARHEG recipients at those institutions deemed to exceed the sum of the resident tuition and the Regional Contract Program’s fee-for-service for dentistry, in order to offset the “gap” in difference. The availability of the forgivable dental loan is essential to the Program because it requires the recipient to return to the state of Arkansas to practice dentistry or repay the loan—further reducing the risk of a shortage of dentists in Arkansas.

Eligibility to participate in the ARHEG Program requires an applicant to be certified as a bona fide resident of Arkansas (AR) through the ARHEG Coordinator at the Arkansas Department of Higher Education (ADHE). ### Eligibility Requirements

Eligibility to participate in the ARHEG Program requires an applicant to be certified as a bona fide resident of Arkansas (AR) through the ARHEG Coordinator at the Arkansas Department of Higher Education (ADHE). Residency status is determined from information provided by the applicant, in the form of verifiable residency documentation that includes, but is not limited to, a copy of original birth certificate, a ten-year residency history, AR voter registration number and date of registration, AR driving license and automobile registration, and previous year's AR state tax return.

## **Arkansas Health Education Grant – Veterinary Loans**

### Establishment

Acts of 2007, Act 488, § 1, eff. July 31, 2007.

### Purpose and Need

The Arkansas Health Education Grant (ARHEG) Program provides assistance for Arkansas residents attending certain out-of-state accredited health and medical professional schools for graduate or professional programs that are not available in Arkansas. The availability of a forgivable loan, in addition to the grant, serves ARHEG recipients at those institutions deemed to exceed the sum of the resident tuition and the Regional Contract Program’s fee-for-service for veterinary medicine, in order to offset the “gap” in difference. The availability of the forgivable veterinary loan is essential to the Program because it requires the recipient to return to the state of Arkansas to practice veterinary medicine (at least 30% must be large animal practice) or repay the loan—further reducing the risk of a shortage of veterinarians in Arkansas.

### Eligibility Requirements

Eligibility to participate in the ARHEG Program requires an applicant to be certified as a bona fide resident of Arkansas (AR) through the ARHEG Coordinator at the Arkansas Department of Higher Education (ADHE). Residency status is determined from information provided by the applicant, in the form of verifiable residency documentation that includes, but is not limited to, a copy of original birth certificate, a ten-year residency history, AR voter registration number and date of registration, AR driving license and automobile registration, and previous year’s AR state tax return.

## Arkansas National Guard Tuition Incentive Program

### Establishment

Acts of 1995, Act 186, § 1, eff. Feb. 7, 1995; Acts of 1995, Act 346, § 1, eff. Feb. 16, 1995.

### Purpose and Need

The purpose of this program is to provide an incentive in the form of a tuition payment to encourage and assist in the pursuit of postsecondary education while making enlistment in the Arkansas National Guard. The program brings Arkansas' incentives for enlistment more in parity with surrounding states. States surrounding Arkansas have increased incentives to National Guard members, including tuition exemptions and waivers of out-of-state tuition for qualified active National Guard members, in part because these states have lost National Guard units. The combined effect of these factors has caused assigned personnel strength in the Arkansas National Guard to decline steadily since early 1994.

### Eligibility Requirements

The Arkansas National Guard Tuition Incentive Program shall consist of an annual tuition incentive award of up to five thousand dollars (\$5,000) per eligible service member, payable at two thousand five hundred dollars (\$2,500) per semester for two (2) semesters with payments made directly to the approved institution. The number of tuition incentive awards shall be limited to the fiscal year appropriation for the program. Tuition incentive awards must be used at an approved institution. Tuition incentive awards are available only for payment toward undergraduate studies at an approved institution. Eligible service members shall complete military training and be awarded a military occupation specialty or Air Force skill code before payment of a tuition incentive award is made. In order to be eligible for a second semester or subsequent semester tuition incentive award, an eligible service member shall continue as a student in good standing at an approved institution and shall continue as a satisfactory participant in the Arkansas National Guard, meeting Good Soldier or Good Airman requirements as certified by his or her unit commander.

## Arkansas Single Parent Scholarship

### Establishment

Acts of 2009, Act 11416.

### Purpose and Need

This program has been created for applicants that are single parents living in Arkansas who are considered economically disadvantaged and who have custodial care of one or more children under the age of eighteen.

### Eligibility Requirements

Guidelines vary from county to county and may include only approved programs of study, approved schools, income level, marital status, grade point average, and eligibility for federal financial aid.

## Higher Education Opportunities Grant (GO! Grant)

### Establishment

Acts of 2007, Act 1030, § 1, eff. April 4, 2007; Acts of 2009, Act 1213, § 2, eff. April 7, 2009.

### Purpose and Need

The purpose of the Higher Education Opportunities Grant Program is to increase the ability of low-income students to pursue higher education opportunities.

### Eligibility Requirements

Student must be a full-time or part-time college student and meet income requirements. Student must complete the YOUniversal Scholarship Application and the Free Application for Federal Student Aid (FAFSA) application. Eligibility is based on the family's adjusted gross income as reported on the Free Application for Federal Student Aid (FAFSA). For a family with one member in the household, the maximum adjusted gross income is \$25,000. For each additional household member the maximum income increases by \$5000, up to a maximum of \$75,000. Award up to \$1,000.

## Law Enforcement Officers' Dependents Scholarship (LEO)

### Purpose and Need

If any Arkansas law enforcement officer, full-time or volunteer firefighter, emergency medical technician, state highway employee, state correction employee, Department of Community Correction employee, state parks employee, teacher, or state forestry employee suffers fatal injuries or wounds or becomes permanently and totally disabled as a result of injuries or wounds that occurred in the performance of a hazardous duty within the scope of his or her employment or that occurred en route to or returning from a location where a hazardous situation existed, his or her children and spouse shall be entitled to a total of eight (8) semesters, or the equivalent thereof, of scholarship awards without cost, exclusive of books, food, school supplies, materials, and dues or fees for extracurricular activities, at any state-supported college, university, or technical institute of his or her choice within this state. Up to four (4) semesters, or the equivalent thereof, may be taken at a technical institute.

### Eligibility Requirements

Scholarship eligibility is determined by the Arkansas State Claims Commission in coordination with other eligibility requirements set forth by the Arkansas Department of Higher Education as follows: dependent child (and/or stepchild) must be under the age of 23 years at the start of beginning semester after award. Spouse may not be remarried. Student must complete the YOUiversal Scholarship Application online and submit supporting documentation no later than June 1. Supporting documentation includes, but is not limited to, a copy of the "Order of Finding of Facts" from the Arkansas State Claims Commission, a copy of the dependent child's original birth certificate; for spouse, a copy of marriage license. Students must complete the YOUiversal Scholarship Application. Application deadline is June 1.

### Purpose and Need

The purpose of this program is to provide a waiver of in-state tuition, on-campus room/board and mandatory fees at an Arkansas institution of higher education. It is necessary to assist full-time undergraduate students who are dependent children or spouses of persons who were declared killed in action, missing in action or service-connected 100% permanently and totally disabled.

### Eligibility Requirements

Scholarship enables students to pursue an undergraduate degree. All applicants of the Military Dependents' Scholarship (MDS) must also apply and show acceptance or denial of the federal program, Dependents' Educational Assistance Program. The MDS Program award will cover any unpaid portion of tuition, fees, room and board not covered by the federal program. Maintain a minimum of a 2.0 grade point average on a 4.0 scholastic grading scale, and complete 24 hours per year.

## Second Effort Scholarship

## Southern Regional Education Board (SREB) Minority Doctoral Scholars

### Establishment

The State Board established Doctoral Scholars Program on October 21, 1994, by agreeing to join the SREB Compact for Faculty Diversity.

### Purpose and Need

The purpose of this program is to encourage minority students to pursue a Ph.D. SREB and its 16 member states recognize that there is an under-representation of minority scholars in doctoral programs and on the faculties of colleges and universities in the region. To address this problem, SREB and its member states have developed a program to increase opportunities for qualified minority students to participate in selected graduate programs leading to a doctoral degree, thereby expanding the pool of persons available to teach at the collegiate level.

### Eligibility Requirements

A candidate must be applying to or enrolled in a Ph.D. program. Scholars in all other doctoral degree programs, including D.B.A., D.D.S., D.N.P., D.P.T., D.V.M., Ed.D., J.D., M.D., Pharm.D., etc. are ineligible to apply. Must be expecting admission into a Ph.D. program before the academic year begins or are within first year of a Ph.D. program. Must have completed all course work and comprehensive/preliminary exams and have defended the prospectus successfully before the academic year begins. Must be accepted into or enrolled in a full-time, campus-based Ph.D. program (not online or distance learning) at a participating institution in a participating state by August, the start of the academic year. Candidates must hold or be scheduled to receive a bachelor's or master's degree from a regionally accredited college or university by the beginning of the fall semester. Must be a U.S. citizen or have legal permanent resident status. Must be a member of a racial or ethnic minority (including African-American, Asian American, Hispanic/Latin American, Native American or others). They must not be employed outside his or her department or discipline. Candidates must plan to become a full-time college or university faculty member after earning their Ph.D.

## State Teacher Education Program (STEP)

The State Teacher Education Program is a loan reduction program created to help teachers who are currently teaching in a geographic or subject shortage area in the state of Arkansas to reduce the burden of their student loans.

### Eligibility Requirements

In order to qualify, an applicant must be a teacher with an education degree earned after 4/1/2004, who is teaching in a public school in a geographic and/or subject shortage area, and who has outstanding federal student loans. Recipients will receive a grant worth up to \$4,000 paid to their federal student lender. Teachers must complete the YOUniversal Scholarship Application. Application deadline is June 1 each academic year.

## Student Undergraduate Research Fund (SURF)

### Establishment

Act 2124 of 2005, Section 32.

### Purpose and Need

Program is designed to allow undergraduate students to conduct in-depth research projects in their specific fields of study with the assistance of faculty mentors. The focus of the Student Undergraduate Research Fellowship is the continued development of undergraduate academic research efforts at Arkansas's public and private institutions of higher education and to provide funding to encourage students to conduct in-depth research projects in specific fields of study under the tutelage of tenured or full-time faculty members. The program is designed to assist all students throughout the state.

### Eligibility Requirements

In order to be eligible, undergraduate students must have a minimum GPA of 3.25, 30 or more hours of credit toward his/her degree at the time of funding, and the support of a faculty mentor. The amount of the fellowship awarded to each recipient shall be as follows:

Applicants complete courses and are reimbursed for allowable expenses. Teachers and administrators must complete the YOUniversal Scholarship Application. Application deadline is June 1 each academic year. The program pays tuition and fees for up to 6 hours per fiscal year. Not to exceed the maximum charged by a public institution.

## Washington Center Scholarship

### Establishment

Acts of 2007, Act 1046, § 2, eff. April 4, 2007.

### Purpose and Need

The purpose of this scholarship is to allow a student the opportunity to participate in the Washington Center internship program. The Washington Center Scholarship Program serves Arkansas students and society as a whole by encouraging participants to be informed, public-spirited and civically engaged for life.

### Eligibility Requirements

Students must be enrolled in an accredited college or university as a second semester sophomore or above; maintain a grade point average of at least 2.75 on a 4.0 scale; receive academic credit from the student's college or university for participation in the internship program; and, receive the endorsement of the student's campus liaison or faculty sponsor. Additionally students must be enrolled in an eligible Arkansas institution that will grant academic credit for participation in The Washington Center Internship Program located in Washington D.C.; meet The Washington Center admission requirements; and, be enrolled in a program of study, which leads to or is creditable towards a baccalaureate degree. The award pays up to \$6,000 for one-time participation in The Washington Center internship program.

## Workforce Improvement Grant (WIG)

### Establishment

Acts of 2003, Act 1796, § 1, eff. July 16, 2003; Acts of 2005, Act 2129, § 3, eff. Aug. 12, 2005; Acts of 2013, Act 1416, § 1, eff. Aug. 16, 2013.

### Purpose and Need

It is the intent of this legislation to provide financial support to adult students who are unlikely to receive meaningful financial aid from traditional state or federal financial aid programs and to enhance the education of the current work force in Arkansas. There is a need to assist Arkansans who desire to pursue educational enrichment and to improve present skills but who may be unable to attend postsecondary educational institutions in the traditional manner are commended for their initiative and persistence.

### Eligibility Requirements

Based on financial need. Funds are allocated to institutions who make awards to their students. Deadlines are set by each school. Student must complete the Free Application for Federal Student Aid (FAFSA). To be eligible, a student must have unmet need after consideration of any Pell Grant awarded and must meet the general eligibility requirements for federal financial aid programs. The annual award is a maximum of \$2000 for a student enrolled full-time (12 semester hours), but may be less in order to prevent an over award as defined by federal regulations. Students enrolled part-time will have their grants prorated based on the number of hours enrolled. Because the grants are not renewable, students must apply each year.
