- **Annual Report on Credentials Awarded**

The Credentials Awarded report is provided as an information item. This report reviews the number of total credentials awarded by public and private institutions and is segmented by the credential degree level.

- **Annual Report of Student Retention and Graduation**

The annual report on Graduation and Retention Rates will be presented to the Coordinating Board as an information item. The report provides fall-to-fall retention and success rate calculations on cohorts of students. In addition, the Graduation Rates calculations provide an IPEDS-based methodology for calculating graduation rates along with corresponding retention and success rates. The graduation rate data is also segmented by gender, race, and age.

- **Annual Report on Retention and Graduation of Intercollegiate Athletes**

The annual report on retention and graduation of intercollegiate athletes will be presented to the Coordinating Board.

- **Annual Report on Productivity of Recently Approved Programs**

Degree productivity of certificate and associate degree programs approved by the Coordinating Board in AY2009 (2008-2009) (after three years) and baccalaureate and graduate degree programs approved by the Coordinating Board in AY2007 (2006-2007) (after five years) will be presented to the Coordinating Board as an information item.

- **Performance Funding Outcomes**

The performance-based funding formulas were reviewed and approved by the Arkansas Higher Education Coordinating Board (AHECB) at its Special Meeting held on December 2, 2011. This report will provide the outcomes for each University and College based on the performance-based funding formulas aforementioned.

- **Policy Amendment: Concurrent Enrollment (AHECB 5.16)**

Arkansas law allows the enrollment of high school students in college-level courses under certain conditions. Concurrent enrollment allows students to obtain credit toward a high school diploma at the same time they earn college credit.

An amendment to AHECB Policy 5.16 will be presented to include guidelines for approval of concurrent enrollment programs and state regulations for concurrent credit.

- The proposed associate degree program health information management is to be offered through traditional instruction on campus beginning in the Fall of 2013. NWACC is also proposing a Health Information Coding Technical Certificate to meet industry and workforce needs. Northwest Arkansas is one of the fastest growing areas in the state, this population growth demands increased healthcare services in all areas. Health coding is one of many occupations that support the healthcare industry. NWACC's HIM Advisory Board recommends that health coding be offered in our community as a means to keep up with the workforce demand. Due to legislative reforms, information security issues, reimbursement and the need to contain healthcare costs, local hospitals in Northwest Arkansas, along with students and local healthcare providers has encouraged NWACC to establish a Health Information Management program for the past several years.

- **Rich Mountain Community College**

- **Cosmetology Technical Certificate**

- The cosmetology course is designed to provide students with the theoretical and practical instruction required as a prerequisite to qualify for licensure examination by the Arkansas State Board of Cosmetology. The primary purpose of the course is to train the student in basic manipulative skills, safety judgments, proper work habits desirable attitudes and appreciation necessary for positions as a cosmetologist. All elements of the technical curriculum are dictated by and shall adhere to the standards of the Arkansas State Board of Cosmetology.

- Beginning Graphic Applications work by students at SAU using visual arts software shows potential using Graphic Apps for the first time. The University of Arkansas for Medical Sciences (UAMS) proposes to offer the state’s first Ph.D. degree program in Epidemiology. As proposed, the program will produce health professionals that are highly trained to identify conditions that impose a heavy disease burden in the state of Arkansas and globally, and thus provide critical information necessary for adequate measures to be applied to reduce disease burden. Hence, Ph.D.-level epidemiologists are vitally important to improving the health of Arkansans and in pursuing the missions of the UAMS and COPH.

A Letter of Intent informs the AHECB of institutions that plan to offer new programs or organizational units that require a proposal and Coordinating Board approval. Chief academic and chief executive officers can comment on the proposed programs and organizational units before the proposals are considered by AHECB.

- **Economic Feasibility of Bond Issue for Arkansas Tech University (ATU)**

Arkansas Tech University (ATU) requests approval of the economic feasibility of plans to issue bonds not to exceed \$1.75 million with a term of 30 years at a rate of approximately 5.25%. Proceeds from the bond issue will be used for auxiliary purposes to renovate and expand Chambers Cafeteria on the campus of Arkansas Tech University. The Arkansas Tech University Board of Trustees will consider this financing at its meeting on March 28, 2013.

- **Economic Feasibility of Bond Issue for University of Arkansas at Little Rock (UALR)**

The University of Arkansas at Little Rock (UALR) requests approval of the economic feasibility of plans to issue bonds not to exceed \$30.5 million with a term of 20 years at a rate of approximately 4.0%. Proceeds from the bond issue will be used for educational and general purposes to fund a complete campus energy management and conservation program. The University of Arkansas Board of Trustees will consider this financing at its meeting on April 5, 2013.

- **Economic Feasibility of Bond Issue for Cossatot Community College of the University of Arkansas (CCCUA)**

Cossatot Community College of the University of Arkansas (CCCUA) requests approval of the economic feasibility of plans to issue bonds not to exceed \$4.15 million with a term of 30 years at a rate of approximately 4.0%. Proceeds from the bond issue will be used for educational and general purposes to acquire certain properties, improvements and educational facilities in Howard County Arkansas through the exercise of an option to purchase under and Arkansas State Lease and Option Agreement. The University of Arkansas Board of Trustees will consider this financing at its meeting on April 5, 2013.

- **Economic Feasibility of Loan for University of Central Arkansas (UCA)**

The University of Central Arkansas (UCA) requests approval of the economic feasibility of plans to secure a loan not to exceed \$3.0 million with a term of 15 years at a rate of approximately 5.0%. Proceeds from the loan issue will be used for auxiliary purposes to defease debt held by the University of Central Arkansas Foundation. The University of Central Arkansas Board of Trustees will consider this financing at its meeting on April 5, 2013.
