## Director's Report

This agenda item will include updates on new employees, legislation and current events.

#### Report on 2018 Fall College-Going Rate

The annual report concerning the College-Going Rate for Arkansas will be presented. Included will be a table detailing the number of first-time entering freshmen by institution for the past five years through Fall 2018 and a comparison to the national college-going rate according to the National Center for Education Statistics.

## Report on Concurrent Enrollment

The annual report on Concurrent Credit will be presented. Arkansas law allows the enrollment of high school students in college-level courses under certain conditions. Concurrent enrollment allows students to obtain credit toward a high school diploma at the same time they earn college credit.

# Report on Faculty Performance Review 2018-2019 (AHECB Policy 5.5)

A summary report on the Annual Review of Faculty Performance will be presented.

## Academic Challenge Scholarship

In accordance with Act 549 of 2019, amendments expand eligibility to students who have an ACT superscore of 19. Students who are receiving the scholarship for the fourth year can now enroll in less than 15 hours and receive a prorated award.

## Arkansas Future Grant (ArFuture) Scholarship

In accordance with Act 618 of 2019, the amendments provide provisions of the Arkansas Futures Grant, including the fields of study that are within the scope of the program, and student mentoring and community service requirements. The list of eligible programs will be expanded to include accounting, finance, nursing, IT, data analysis and graphic design. The community service requirement will be lowered from 15 hours per semester to 10 hours per semester.

#### Governor's Distinguished Scholarship

In accordance with Act 834 of 2019, recipients of Arkansas Governor's Distinguished Scholarships can continue to receive proceeds on a prorated basis while enrolled part-time.

## State Teacher Education Program (STEP)

In accordance with Act 603 of 2019, the amendments to the State Teacher Education Program (STEP) provide that an individual who earns a teaching license upon successful completion of the Non-Traditional Licensure Program or the Professional Pathway to Educator Licensure program are now eligible for STEP.

#### FINANCE COMMITTEE

#### Certification of Intercollegiate Athletic Budgets for 2019-20

A.C.A. §6-62-805 directs institutions of higher education having intercollegiate athletic programs to certify annually that their intercollegiate athletic programs will generate sufficient revenues to meet budgeted expenditures, or that any athletic deficit will be met by separate institutional, board-sanctioned student athletic fees.

Each institution having an intercollegiate athletic program responds with submission of both ADHE Form 21-2 and a copy of its Board resolution approving the athletic operating budget for the 2019-20 fiscal year.

### Economic Feasibility of Bond for Southern Arkansas University (SAUM)

Southern Arkansas University requests approval of the economic feasibility of plans to issue bonds not to exceed \$15.1 million with a term of 20 years for educational and general purposes and 15 years for auxiliary purposes at a rate of approximately 3.13%. The educational and general proceeds not exceeding \$6.35 million will be used to refund the 2013A Series bonds. Auxiliary proceeds not exceeding \$8.75 million will be used to refund the 2014 Series bonds. The Southern Arkansas University Board of Trustees approved this financing at its meeting on May 30, 2019.

#### Economic Feasibility of Bond for University of Arkansas, Fayetteville (UAF)

The University of Arkansas, Fayetteville requests approval of the economic feasibility of plans to issue bonds not to exceed \$31.25 million with a term of 15 years for auxiliary purposes at a rate of approximately 4.5%. Proceeds from will be used for (1) acquisition, construction, furnishing and equipping an approximately 25,000, sq. ft. track and field high performance center for men's and women's track and field teams; (2) acquisition, construction, furnishing, and equipping of an approximately 45,000 sq. ft. baseball development center at Baum-Walker Stadium; and (3) the acquisition, construction, improvement, renovation, equipping and/or furnishing of other capital improvements and infrastructure for athletic purposes, and the acquisition of various equipment for athletic purposes. The University of Arkansas Board of Trustees approved this financing at its meeting on June 17, 2019.

# Economic Feasibility of Loan for Ozarka College (OZC)

Ozarka College requests the approval of the economic feasibility of plans to obtain a bank loan not to exceed \$400,000 with a term of 15 years for educational and general purposes at a rate not to exceed 4.0%. Proceeds from the loan will be used to purchase a facility in Ash Flat (Sharp County) to be used as a Technical Center. The Ozarka College Board of Trustees approved this financing at its meeting on July 2, 2019.

#### Northwest Arkansas Community College

New Off-Campus Instruction Center–Washington County Location, Springdale, AR NWACC is proposing a new off-campus site in Springdale, AR, called NWACC Washington County. The proposed site will offer the Associate of Arts, Associate of Science in Liberal Arts & Sciences, Associate of Applied Science in Nursing, and Associate of Applied Science in Health Information Management degrees. The proposed programs can be completed through a combination of distance, online, and onsite modes. NWACC Washington County is approximately 38,000 square feet and is comprised of 17 classrooms, including three with science labs and one nursing simulations lab. Open work areas will be utilized for staff in lieu of standard office formats.

## University of Arkansas, Fayetteville Bachelor of Arts in Arabic

The proposed Bachelor of Arts in Arabic is 120 credit hour program designed to help students achieve high levels of fluency in Arabic languages, literature, and culture while developing tools to think about and engage critically with the Arab world. Students who major in the proposed program will have the opportunity to combine their Arabic language study with Middle East Studies and International and Global Studies, further strengthening and broadening their language and culture studies. The proposed major prepares students for graduate work in comparative literature, literacy and non-literary translation, anthropology, geography, history, political science, international relations, economics, and gender studies. Graduates may pursue job opportunities in the United States or Arab World with organizations such as the Arab American Chamber of Commerce, various Arab embassies and consulates, international banks, American foreign relations, the United States government, and in various businesses or the oil industry.

## Master of Education in Community College Leadership

The proposed Master of Education in Community College Leadership will be an online 33 credit hour graduate program for individuals who work in community colleges who seek to build their content expertise and improve career mobility. The proposed program focuses on preparing individuals for community college leadership and administrative roles. Prospective students should have a bachelor's degree and some experience working at a community college. Graduates will understand and gain knowledge of the historical development, contemporary challenges and different functions of community colleges.
