EXECUTIVE BUDGET SUMMARY

For the Fiscal Year Ending June 30, 2017

Mission and Organization

The University of Arkansas Community College at Batesville provides quality educational opportunities within a supportive learning environment. We promote success through community partnership, responsive programs, and an enduring commitment to improvement.

Goals

In order to accomplish its mission and fulfill its vision, UACCB has established a set of strategic goals. Each organizational area is expected to work towards its respective goals and correspondingly contribute to the strategic institutional efforts.

Budget Assumptions and Philosophy

The FY17 budget is based upon General Revenue of \$4,131,061 in Category A and a Workforce 2000 forecast of \$866,760, the FY16 level. The Administrative Cabinet members worked with their area budget managers in developing this budget. The FY17 budget sets a direction toward improving student success and retention and meeting the needs of our community through community based programs. The budget is also designed to more closely align with the institution's strategic plan.

The operating budget was developed assuming the following:

- State appropriations will remain the same as FY16
- Revenue from the ¼ cent county sales tax is projected to generate \$1,300,000
- No tuition increase for FY17. Facilities fee is to be increased by \$2 per credit hour and technology fee to be increased by \$4 per credit hour with \$1 reserved for the system ERP. SSCHs are projected to increase by approximately 2% above the FY16 actual SSCHs
- Department operating budgets were formulated very closely to the 2016 levels
- Continuation of third-party vendor for default management services. Anticipated that evening custodial will be outsourced on July 1.
- Debt service for FY17 will be set at \$394,624. This debt service includes the annual obligation for the existing bond issue for Independence Hall. This debt payment also includes a payment to the Arkansas Revolving Loan Account in which funds were used to assist in the construction of the Nursing and Allied Health Building.

Estimated Revenues

Revenues for FY17 are projected to increase from FY16 revenues because of an estimated increase in enrollment in technical courses and concurrent enrollment. State appropriation funding for FY17 is projected at \$4,131,061 in Category A, the same as the overall FY16 General Revenue appropriation. Workforce 2000 funds are projected at \$866,760. Local sales tax is projected at \$1,300,000.

Budget Allocations

The budget was prepared with sensitivity to the projected needs of the campus as it continues to develop and cope with the economic situation. Reallocations have been made to cover the cost of departmental budgets.

Scholarships remain a very important part of the UACCB mission. The FY17 budget has funded our student scholarship account at \$381,000, an increase of \$60,000 from FY16. This budget funds institutional scholarships and financial awards.

Debt service for FY17 is \$394,624. This debt service includes the annual obligation for the existing bond issue for Independence Hall. This debt payment also includes a payment to the Arkansas Revolving Loan Account in which funds were used for the construction of the Nursing and Allied Health Building. Final payments to the Arkansas Development Finance Authority (ADFA) loans for the construction of a Maintenance Facility and Library/Academic Facility were completed during FY16.
