Planning Commission - In all cities and towns, the legislative body of the municipality may create a planning commission of not less than 5 members. ACA 14-56-404(a)(1)). Ordinance shall also provide for a board of zoning adjustment or commission as a whole may fill that role. To receive the benefit, Mayors must have served in that capacity for more than ten (10) years upon reaching sixty (60) years of age, or for twenty (20) years at any age. Id. Mayors may receive credit for years served as an elected official or employee. ACA 24-12-123(a)(3)(A).</p>	<p>Mayor Retirement – Mayors receive retirement benefits if approved by, and in an amount prescribed by, the city council. ACA 24-12- 124(b). To qualify, mayors must have served at sixteen (16) years upon reaching age sixty-five (65), or have served twenty (20) years at any age. ACA 24-12-124(a)(1).</p>	<p>No retirement benefits for Mayors provided by statute. See ACA 24-12-101 et seq.</p>
<p>City Clerk Retirement – City clerks may receive a monthly retirement benefit totaling one-half of the monthly salary earned in their last year of office. ACA 24- 12-121(b)(1). To qualify, city clerks must have served in that capacity for at least ten (10) years upon reaching the age of sixty (60), or twenty (20) years for any age. ACA 24-12-121(a)(1). City clerks may receive credit for years served in other capacities, if approved by city council. ACA 24-12-121(c)(1).</p>	<p>Recorder-Treasurer Retirement – If approved by the city council, ACA 24-12-127(a)(1), treasurers may receive a retirement benefit totaling one-half of the monthly received in their last year of office. ACA 24-12-127(b)(1). To qualify, treasurers must serve in that capacity for more than ten (10) years upon reaching the age of sixty (60), or twenty (20) years upon reaching any age. ACA 24-12-127(a)(1).</p>	<p>No statutory retirement benefits for recorder-treasurers. See ACA 24-12-101 et seq.</p>
<p>Treasurer Retirement – If approved by the city council, ACA 24-12-125(a), a city treasurer is eligible to receive a retirement benefit totaling one-half of the monthly salary received in his or her last year of office. To qualify, treasurers must have served in that capacity for fifteen (15) years and be at least sixty (60) years of age. ACA 24-12-125(a).</p>	<p>Treasurer Retirement – See above.</p>	<p>No separate Treasurer position. ACA 14-45-108.</p>
