**Special Election for the City of North Little Rock**

**PULASKI COUNTY, AR** – A special election for residence in the city limits of North Little Rock is set for Tuesday, February 14 and Pulaski County Circuit and County Clerk Terri Hollingsworth has some important reminders for voters.

North Little Rock voters will weigh in on increasing funding for the library system by deciding to raise the current rate of 3 mills to 5 mills.

There are approximately 37,942 eligible registered voters for this election. North Little Rock residents who are unsure if they are qualified to vote can use the Arkansas Secretary of State's [VoterView](#) website to check a sample ballot and find their polling location. The last day for new voters to be qualified to vote in this election was January 17. The last day voters who live outside Pulaski County can transfer their voting address within the North Little Rock city limits and be eligible to vote is **February 10**.

**EARLY VOTING**

There are five (5) days of early voting beginning Tuesday, February 7 and ending Monday, February 13. There will be no early voting on Saturday or Sunday. There will be three locations for early voting:

**1. Pulaski County Regional Building**

Last day to early vote at this location is Monday, February 13

**2. William F. Laman Library**

2801 Orange St, North Little Rock

10:00 a.m. – 5:00 p.m.

Last day to early vote at this location is Friday, February 10

**3. Glenview Community Center**

4800 E. 19th St., North Little Rock

10:00 a.m. – 5:00 p.m.

Last day to early vote at this location is Friday, February 10

**ELECTION DAY**

Eligible voters must vote at their assigned polling location on election day. The polls will be opened from 7:30 a.m. until 7:30 p.m.

**ABSENTEE VOTING**

Eligible voters have until February 7 to email, mail or fax a request for an absentee ballot to be mailed. The deadline to request an absentee ballot application *in person* at the courthouse by the voter and/or their designated bearer/administrator is February 10 before 5:00 p.m.

Absentee ballots returned *in person* must be turned in by February 10 before 5:00 p.m. to the courthouse. Ballots that were mailed in by the voter must be received by the County Clerk’s office before 7:30 p.m. on election day.

**ELECTION DAY POLLING LOCATION CHANGES**
