IMPORTANT PULASKI COUNTY ELECTIONS INFORMATION
THREE DAYS OF EARLY VOTING REMAIN IN MARCH 3, 2020 ELECTIONS

(LITTLE ROCK, ARK.) – In advance of the final weekend of early voting in the March 3, 2020 elections, Pulaski County Circuit and County Clerk Terri Hollingsworth shared important information for registered voters with community, educational, civic organizations, and the media.

“Voter education plays a pivotal role in our elections. To encourage more residents to register and then to vote in future elections, my office has placed a greater emphasis on getting information out across the county.

We want to make the election process as easy, accessible, and as fun as possible for Pulaski County voters. Sharing information is the most effective way to do so,” said Hollingsworth

EARLY VOTING

- Pulaski County voters have three more days to early vote.
- Early voting for the March 3, 2020 Preferential Primary/Nonpartisan General (Judicial) and Annual School Elections began on Tuesday, February 18.
- Early voting runs through Monday, March 2, 2020.
- No early voting is available on Sunday, March 1, 2020.
- Only one early voting location is open on Monday, March 2, 2020, the Pulaski County Regional Building at 501 West Markham Street in Little Rock, 8:00 a.m. – 5:00 p.m.
- Through Friday, February 28, the hours of early voting at the Main site are: 8:00 a.m. – 6:00 p.m. On Saturday, February 29, the hours are 10:00 a.m. to 4:00 p.m.
- Two new offsite early voting sites have been added: The Central Arkansas Library Systems (CALs) Hillary Clinton Children’s Library and the John Gould Fletcher Library in Little Rock.
- Early voting hours have also been extended to close later.
- Election Day is Tuesday, March 3, 2020, 7:30 a.m. – 7:30 p.m. Registered voters will go to their local polling sites.

ELECTION DAY

Polls will be open from 7:30 a.m. to 7:30 p.m. on Tuesday, March 3, 2020. Registered voters must present their photo ID.

If a voter is unable to verify their registration by presenting proper identification (photo ID)- they should ask for a provisional ballot. They will have until 12:00 p.m. noon on Monday, March 9, to provide proper identification at the Pulaski County Election Commission or County Clerk Voter Registration office.

The Pulaski County Circuit and County Clerk is Terri Hollingsworth. Hollingsworth was sworn-in to office on January 1, 2019. Pulaski County is one of 18 counties that has combined the two clerk positions. As county clerk, Hollingsworth also serves as the Pulaski County Voter Registrar.

The clerk's staff processes voter registration, registration updates and transfers (for changes of address,) and maintains the county's voter registration data. The staff also processes requests, distributes and receives absentee ballots.
