ANNOUNCES EXTENSION OF TEMPORARY OPERATIONS THROUGH APRIL 17**

Clerk also urges Pulaski County residents to complete the U.S. Census

(LITTLE ROCK, ARK.) – In compliance with Pulaski County County Judge Barry Hyde's most recent [executive order](#), Terri Hollingsworth announced an extension of temporary operations at the Pulaski County Circuit and County Clerk's offices. The courthouse will remain closed to the public. Limited services will be available onsite from 8:00 a.m. – 4:00 p.m. Monday through Friday.

"As we enter April, I ask you to continue social distancing and staying home for the safety for yourself and others. As mandated, the courthouse and our office will remain closed to the public through April 17, 2020.

Our office continues to serve customers through our website, in conversations over the phone and email, and through the mail. In very limited cases, a trip to the courthouse to conduct business may be necessary. Call our main number (501) 340-8500 or the appropriate department before you consider coming to our offices. We sincerely appreciate your understanding and patience," said Terri Hollingsworth, Pulaski County Circuit and County Clerk.

"During this uncertainty and naturally distracting time, we must still remember to participate in the census. April 1 is Census Day and I encourage all Arkansans, especially those of us in Pulaski County, to participate in the 2020 U.S. Census. I did so online and it took me only seven minutes! It is easy and its importance cannot be emphasized enough. Visit www.my2020census.gov to complete the form online. You may also participate via phone or mail," added Clerk Hollingsworth.

As required, a small number of transactions and business is conducted in person at the clerk's office, including:

- Requests for orders of protection may be made in person at the courthouse.
- Commissioner Sales will take place as scheduled weekly on Thursdays at 12:00 p.m., and will be conducted outside the Pulaski County Courthouse's Markham Street entrance. Sales are listed on the clerk's website.

Any customers considering coming to the courthouse should call first before doing so.

Using the clerk's website, www.pulaskiclerk.com, customers can access court orders, real estate records, official forms, data searches, and individual department phone numbers and email addresses.

Those unable to use the website, can call the appropriate department and staff for assistance. Staff will advise whether a trip to the courthouse is necessary.
