# NATIONAL VOTER REGISTRATION ACT (NVRA) BACKGROUND

The National Voter Registration Act of 1993 set up national guidelines and requirements for allowing voters to be given the opportunity to register to vote or change their voter registration information when seeking or receiving services such as a driver's license or public assistance.

Under the law (Amend 51, §10, (d)), the Pulaski County Clerk's Voter Registration Office is to conduct bi-annual confirmation mailings to those individuals with whom we didn't have contact during the past two-year election cycle, (2017-2018). These individuals didn't vote nor update their registration information during the cycle. The mailings ask the voter to either confirm their address or update their registration information.

The mailing asks the voter to either confirm their address or update their registration information. A postcard is built into the mailer, which enables the voter to mail back their response at no cost to them. Additionally, the voter has the option to call the Voter Registration Office to update their information.

The above card will be sent to every registered voter who didn't vote or update their information during the 2017-2018 election cycle. The NVRA process recategorizes these voters into the "inactive" status. They have all the rights of an "active" status voter, meaning their names will be printed on the poll book, and they can vote in any election in which they are eligible. This is an administrative status only.

If the voter votes in any election or confirms their address, we will place the voter back into "active" status. If they are in the "inactive" status for two complete federal election cycles, they are subject to be made removable, and their voter registration can be cancelled.

Additionally, we are required by the NVRA to send out notices of cancellation due to inactivity for more than two federal election cycles, Amend 51, §11, (f). The Notice of Impending Cancellation is sent to those who would have received the above notice during the 2015 and the 2017 off-year confirmation mailings. If the voter does not respond, their registration will be cancelled. Specifically, if the voter will have to fill out a new Voter Registration application and will be subject to the rules applicable to newly registered voters, such as the 30 days out deadline, etc.

#### NOTICE OF IMPENDING CANCELLATION OF VOTER REGISTRATION

According to our records you have not responded to our address confirmation notice and you have not voted in any election during the period beginning on the date of the notice and ending on the day after the date of the second general election for federal office after the date of the first notice. This may indicate that you no longer live at the residence address printed on the postcard. If your permanent residence address is still the same as the printed address on this postcard YOU MUST CONFIRM YOUR RESIDENCE ADDRESS in order to remain on the voter registration list. If you do not return the attached postcard within thirty (30) days after the date postmarked on this card YOUR REGISTRATION WILL BE CANCELLED and you will have to re-register to vote.

Our current vendor is SourceOne Output, here in Little Rock. Our contact is Paul Enderlin. We have developed a good working relationship with them since they won the contract a few years ago. Using the vendor to handle the mail has removed a significant burden from our Voter Registration office.

The total number of cards we will end out for in this year's mailing will be 56,697. We will send out 52,697 confirmation cards and 4,000 cancellation cards. Postage for the 52,494 confirmation cards being sent out next week is \$5,971.27.

For reference, in 2017, we sent out around 36,581 cards. In 2015, we sent out around 67,644 cards. The reason for the smaller numbers in 2017 and 2019 is due to the higher turnout in the elections of the preceding year.
