ARKANSAS HOUSE DISTRICT 36 SPECIAL ELECTION INFORMATION Important election deadlines, dates, and information for registered voters in District 36

(LITTLE ROCK, ARK.) – Deadlines, dates, and other important information have been finalized for the Special Election to fill the vacancy in office for Arkansas House of Representatives, District 36. The district is in southern Pulaski County and includes College Station, Sweet Home, Woodyardville, Ironton, Wrightsville, Hensley, and portions of Little Rock.

Early voting will begin Tuesday, July 30 and end Monday, August 5. There is no weekend early voting for this election. The Special Primary Election is Tuesday, August 6, 2019. If required, the Special Election Runoff will be Tuesday, September 3, 2019. In the case of a runoff election, early voting will be Tuesday August 27 – Friday, August 30, 2019.

The Pulaski County Circuit and County Clerk is Terri Hollingsworth. Hollingsworth was sworn-in to office on January 1, 2019. Pulaski County is one of 18 counties that have combined the two clerk positions. As county clerk, Hollingsworth serves as the Pulaski County's Voter Registrar. The clerk staff processes new voter registration and registration change forms. The staff also distributes and receives absentee ballots.

The Pulaski County Election Commission manages the selection and administration of polling places, supervision of poll workers, and the counting of votes.
