

Minutes of the
Special Working Meeting of the Shannon Hills City Council Members
Working on the Codification Book
August 27, 2011

Aldermen Brenda McCann, Sue Skipper, Toni Cobb, and James Frala met to work on the Codification Book as planned at the August Regular Council Meeting. Recorder Sandra Vosburg called the meeting to order ((14-42-111). Alderman Skipper moved to appoint Mrs. Vosburg Chairman Pro Tempore for the meeting, seconded by Alderman Frala, and unanimously carried. The committee started review of the ordinances not used in the codification and began marking the ordinances needing further action by the entire City Council.

The group adjourned from 12:50 p.m. until 1:45 p.m. for lunch. Meeting was called to order by Mrs. Vosburg at 1:45 p.m. when work continued. The Committee addressed the following:

- 79-02 – An amendment need to be made to increase the fine in Section 2 to be no less than \$200.
- 79-12 - Repeal.

- 80-02 - Social Security – Amendment needs updating to change who can enter into agreement. Currently states Mayor and Treasurer/Recorder. Council members questioned if an alderman should be listed as well but decided that was not necessary. Just take Recorder off and leave Treasurer.
- 80-03 – Discharging Firearms – Good but amend the amount on fine.
- 80-04 – C-H Communications – Repeal if not already done so, obsolete.
- 80-05 – Curfew – Amended by 2002-09
- 80-06 – 5 mil tax on real property – repealed by 81-18
- 80-07 - Creating Police Dept. - Repealed - not used in codification
- 81-01 – Creating Police Dept. – Tabled – not used in codification
- 81-02 – Creating Police Dept. – Repealed – not used in codification
- 81-03 – Sanitation Dept. - Tabled
- 81-04 – Telephone Franchise - Active
- 81-05 - Telephone Franchise - Obsolete
- 81-06 – AP&L Franchise Tax – Repealed 83-09
- 81-07 – Arkla Franchise Tax – replaced by 96-08
- 81-08 – First Electric Cooperative – Active
- 81-09 – Licensing and Control of Dogs – Replaced by 88-08 and 2003-03
- 81-10 – Control of Nuisances – Active and Amended by 87-01
- 81-11 – Orderly Growth – Repealed by 81-21
